Regarding regularization, the services of Daily Waged
workers who have been/are being deployed to other
Govt. Departments on secondment basis from Surplus
Pool.

Sir,

I am directed to invite a reference to this Department's
letter of even number dated 12.2.2013 on the subject cited above. Of
late references are being received from various Departments seeking
clarification with regard to determination of seniority for the purpose
of regularization of those daily wagers who have been deployed from
surplus pool to other Govt. Department(s) on secondment basis. The
matter has been considered in the Finance Department and it has
been decided that while examining such proposals, the following
conditions may be kept in view:-

- i) A daily wager on being declared surplus and deployed
on secondment basis from one Department to another
shall be placed below the daily wagers borne out of the
cadre of the borrowing Department, based on his/her
date of joining in the borrowing Department.
- ii) The service rendered by a daily wager in the lending
Department on being deployed from surplus pool will be
counted with the service rendered in the borrowing
Department for the purpose of regularization. But
he/she will be considered for regularization as per the
policy/instructions relating to regularization of daily
wagers only after the regularization of the daily wager
senior to him/her in the borrowing Department, as per
condition no. (i).
